## **ECN Capital Reports US \$0.03 in Adjusted Net Income per Common Share in Q2-2024 Solid Q2 2024 Results**

**Toronto, Canada – August 7, 2024** – ECN Capital Corp. (TSX: ECN) ("ECN Capital" or the "Company") today reported financial results for the three-month period ended June 30, 2024.

For the three-month period ended June 30, 2024, ECN Capital reported **Adjusted net income (loss) applicable to common shareholders** from continuing operations of \$8.2 million or \$0.03 per share (basic) versus (\$0.3) million or nil per share (basic) for the previous three-month period and \$0.7 million or \$0.01 per share (basic) for the same period last year.

"We are excited to print another solid quarter with Adjusted EPS of \$0.03 in line with our guidance of \$0.02 to \$0.04", said Steven Hudson, CEO of ECN Capital Corp. "Improved pricing and operational efficiencies have our Triad team on target for its earnings outlook, while our RV and Marine segment delivered strong originations growth. The first two quarters have delivered as planned. We are reaffirming our full year 2024 guidance of \$0.10-\$0.16."

**Originations** for the three-month period ended June 30, 2024 were \$622.5 million, versus \$468.4 million in the previous three-month period and \$622.0 million for the same period last year. Originations for the three-month period ended June 30, 2024 include \$310.9 million of originations from our Manufactured Housing Finance segment and \$311.6 million of originations from our Recreational Vehicle and Marine Finance segment.

**Managed Assets** as at June 30, 2024 were \$5.3 billion versus \$5.2 billion as at March 31, 2024 and \$4.7 billion as at June 30, 2023.

**Adjusted EBITDA** for the three-month period ended June 30, 2024 was \$31.5 million versus \$21.8 million for the previous three-month period and \$24.5 million for the same period last year.

**Operating Expenses** for the three-month period ended June 30, 2024 were \$26.5 million versus \$27.8 million for the previous three-month period and \$26.0 million for the same period last year.

**Net (Loss) Income attributable to common shareholders** for the three-month period ended June 30, 2024 was \$5.6 million versus (\$8.50) million for the previous three-month period and (\$30.0) million for the same period last year.

### **Dividends Declared**

The Company's Board of Directors has authorized and declared a quarterly dividend of C\$0.01 per outstanding common share to be paid on October 1, 2024 to shareholders of record at the close of business on September 13, 2024. These dividends are designated to be eligible dividends for purposes of section 89(1) of the Income Tax Act (Canada).

The Company's Board of Directors has authorized and declared a quarterly dividend of C\$0.4960625 per outstanding Cumulative 5-Year Rate Reset Preferred Share, Series C (TSX: ECN.PR.C) to be paid on October 1, 2024 to shareholders of record on the close of business on September 13, 2024. These dividends are designated to be eligible dividends for purposes of section 89(1) of the Income Tax Act (Canada).
